## PER 2011 USATF COMPETITION RULE BOOK, USATF RULE 305.2(B):

Athletes who compete in the Junior National Championships or World Youth Championships may be entered in the National Junior Olympic meet without having to compete in the Association or Regional meet provided that they meet the Youth Athletics age limits. Acquisition of the waiver and completion of the entry to the National meet must be made *prior* to the Regional meet via the Regional Coordinator. A special provision will be allowed in 2011 that permits athletes who compete in the World Youth Trials to also be "waived" to the National Junior Olympic meet following the same procedures as detailed above.
